







Traffic volume and congestion


PROPOSED IMPROVEMENTS

- Reconstruct Rittiman Road, Gibbs Sprawl Road, and Castle Cross overpass
- Improve rail crossing for motorists
- Ensure safety for the mobility of freight and goods

2023 Transportation Alternatives (TA)

Federal Grant Opportunities



- TxDOT released call for projects in December 2022
- Funding projects for variety of alternative transportation projects that enhance and improve safety for bicycle and pedestrians:
 - Bicycle infrastructure improvements
 - Shared use paths
 - Sidewalks improvements
 - Development of active transportation planning documents

Who Ordinance Applies To?

Contractors for low-bid construction contracts.

Responsible Bidder **Criteria**

Awarding contracts or entering into agreements with contractors:

- Not indebted to the City
- Not involved in any active frivolous claim or litigation against the City
- Does not fail to disclose a violation of criminal law
- Has not had previous contract terminated
- With a history of performing contractual obligations (i.e. quality and timely work)

Heat Illness Prevention for Construction Workers




Council Consideration Request

Request

Creation of an ad hoc task force charged with evaluating and recommending heat illness prevention measures the City and Construction industry can take to ensure construction worker safety.
